

## **ATB FUNDS 2024 DISTRIBUTIONS**

December 31, 2024

The Compass Portfolios and ATBIS Pools pay distributions on a semi-annual basis for the Conservative, Conservative Balanced, Balanced Portfolios, and ATBIS Fixed Income Pool. Distributions are paid annually for the Balanced Growth, Growth, Maximum Growth Portfolios, and ATBIS Canadian Equity, ATBIS US Equity and ATBIS International Equity Pools. For unit holders of record on December 30, 2024, annual distributions were payable December 31, 2024. Information on T3 reporting (the breakdown of the income portion of the distributions) for tax purposes is estimated to be available in March 2025.
