Management Discussion of Fund Performance

Investment Objectives and Strategies

The ATBIS Fixed Income Pool's ("Pools") objective is to seek to earn interest income primarily by investing in, or gaining exposure to, Canadian dollar-denominated fixed income securities, including debt obligations of, or guaranteed by, Canadian federal, provincial or municipal governments, Canadian corporations, or foreign issuers (Maple bonds).

To achieve the Pool's objectives, the Pool's advisor will allocate the Pool's exposure to fixed income securities based upon its view of the market and the suitability of the investment for the Pool and by taking into account factors such as economic indicators (including growth, inflation and monetary policy), as well as its interest rate outlook.

Risk

There were no significant changes to the investment objective and strategies that affected the Pool's overall level of risk during the reporting period. The risks of investing in the Pool and the suitability of the Pool for investors remain as discussed in the Simplified Prospectus.

Results from Operations

The Pool's net asset value increased to \$353 million as at December 31, 2023, from \$246 million at the end of 2022. The change in asset value was due to a combination of net inflows and positive investment returns.

For the year, the Pool's Series O units returned 8.44%, outperforming the benchmark return of 6.69%. The Pool's return is after the deduction of fees and expenses, while broad-based index and blended benchmark returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

The first half of 2023 saw headline inflation globally begin to moderate. Higher interest rates put stress on bank balance sheets causing some regional bank failures in the US and abroad in the first quarter. Central banks provided necessary backstops, and continued their hawkish rhetoric reinforcing their commitment to reducing inflation back to target levels. Through the back-half of the year, commodity prices remained low despite the emergence of a new geopolitical conflict between Israel and Hamas. The last two months in particular saw market sentiment shift towards the expectation of rate cuts in 2024 rallying both stock and bond markets. A potential soft-landing for global developed markets is possible, but the central banks remain vigilant emphasizing that further rate hikes could still be possible should inflation flare up again.

The Bank of Canada raised its short-term target rate through 2023 from 4.25% to 5% as central banks globally continued their efforts to temper rising inflation. Bond yields rose for the first three quarters of the year, as central banks remained resolute in taming inflation. The last quarter of the year saw inflation continuing to decline, leading to soft tones out of central banks, resulting in yields falling and corporate bond spreads narrowing. Narrowing spreads benefitted the Pool's holdings as it is invested in a higher weighting of corporate bonds compared to the broad Canadian investment grade universe. The Pool's allocation to high yield bonds also saw price increases on average as high yield spreads came down through the year. The commercial mortgage component continues to have an attractive ongoing yield with performance that is less influenced by the volatility in bond and equity markets.

A focus over the past couple years has been increasing the average credit quality of the Pool, and that continued through 2023. The Pool overall is positioned defensively for both the possibility of further volatility in interest rates, but also for the potential for deteriorating credit markets on pressures from far higher rates compared to the last decade.

In summary, 2023 allowed investors to sigh with relief and pare losses, with bond markets posting strong returns. Overall, inflation seems to be declining, and markets expect a slowdown for next year, leading to central bank rate cuts sooner rather than later. Whether we see an eventual recession or a soft landing remains to be seen, but we remain cautiously optimistic. The pool is well positioned to help mitigate the short-term impact of volatility and achieve our portfolio investment objectives over the long run.

Recent Developments

There are no developments or changes to report at this time related to the investment objectives, investment strategies or management of any of the ATB Funds, or to the policies of the Independent Review Committee ("IRC").

Related Party Transactions

The Portfolio is managed by ATB Investment Management Inc. ("ATBIM" or the "Manager"), a wholly owned subsidiary of ATB Financial.

The Manager provides the Portfolio with administrative services, including providing key management personnel to the Portfolio. In return the Manager receives an administrative fee which is allocated among the Series based on the average net asset value of each Series. Administrative expenses (excluding GST) paid by the Portfolio to the Manager for services provided by ATB Financial and its subsidiaries were \$65,935 for the period ended December 31, 2023 (\$77,882 - December 31, 2022).

As of December 31, 2023, ATBIM has absorbed \$284,032 of operating expenses in the Pool.

ATBIM is the sole investor in Series A of the Pool. As at December 31, 2023, ATBIM held 619 redeemable units, valued at \$5,897 representing 0.002% of the total net asset value of the Pool.

ATBIM established an IRC which acts as an impartial and independent committee to review and provide recommendations or, if applicable, approvals with respect to any conflict of interest matters. IRC oversight ensures that there are no conflicts of interest that would be harmful to unitholders.

Management Fees

ATBIM receives management fees of 1.25% per annum for Series A and 0.50% per annum for Series F1. The management fees for Series A and Series F1 are calculated as a percentage of their net asset value as of the close of business on each business day. Management fees for Series O are payable directly to the Manager by Series O investors and not by the Pool.



There are no trailer fees associated with the Fund.


Past Performance
