Management Discussion of Fund Performance

Investment Objectives and Strategies

The ATBIS Canadian Equity Pool's ("Pools") objective is to seek to achieve long-term capital appreciation primarily by investing in, or gaining exposure to, equity securities of Canadian companies, including common and preferred shares, and income trusts.

To achieve the Pool's objectives, the Pool's advisor will allocate the Pool's exposure to Canadian equity securities based upon its view of the market and the suitability of the investment for the Pool and by taking into account factors such as market sector, investment style, volatility, and market capitalization.

Risk

There were no significant changes to the investment objective and strategies that affected the Pool's overall level of risk during the reporting period. The risks of investing in the Pool and the suitability of the Pool for investors remain as discussed in the Simplified Prospectus.

Results from Operations

The Pool's net asset value increased to \$279 million as at December 31, 2025, from \$196 million at the end of 2024. The change in asset value was due to a combination of net inflows and positive investment returns.

For the year, the Pool's Series O units returned 19.11%, underperforming the benchmark return of 31.68%. The Pool's return is after the deduction of fees and expenses, while broad-based index and blended benchmark returns do not include any costs of investing. See the Financial Highlights section for the management expense ratios and the Past Performance section for the returns of any other series, which may vary because of differences in management fees and expenses.

The year 2025 unfolded as a period of transition for global financial markets, marked by a gradual recalibration of monetary policy, resilient economic activity in North America, and uneven but improving conditions across international markets. Investor sentiment evolved throughout the year, balancing optimism around technological innovation - particularly in artificial intelligence ("AI") and productivity-enhancing capital investment - against persistent geopolitical risks, shifting fiscal dynamics, and lingering inflationary pressures in certain regions.

Equity markets broadly delivered positive returns over the period, supported by steady corporate earnings growth and a moderation in interest rate policy. As concerns around tariffs and global uncertainty faded in the second half the year, it provided a constructive backdrop for equity markets to climb to new highs.

Canadian markets in 2025 reflected a balance between domestic economic resilience and sensitivity to global macroeconomic trends. The year was characterized by moderating inflation, a gradual easing in financial conditions, and continued strength in employment, which supported consumer activity despite higher borrowing costs earlier in the period. The energy and materials sectors were influenced by commodity price fluctuations and global demand dynamics, while financials benefited from stable credit quality and ("normal") positive sloping yield curve. As a result of global factors, Canadian equities was one of the top performing regions.

Recent Developments

The Fund remained focused on maintaining diversification across sectors and styles, while emphasizing quality, valuation discipline, and risk management as central pillars of the investment process.

The Fund delivered positive returns for the year, supported by contributions from asset allocation decisions. While the underlying sub-advisors targeted different investment styles, they collectively shared a large underweight to materials. Late 2025, we added a targeted Gold Equity ETF to shrink the underweight in a positively performing sector, which was a value add.

There are other developments or changes to report at this time related to the investment objectives, investment strategies or management of any of the ATB Funds, or to the policies of the Independent Review Committee ("IRC").

Related Party Transactions

The Pool is managed by ATB Investment Management Inc. ("ATBIM" or the "Manager"), a wholly owned subsidiary of ATB Financial.

The Manager provides the Portfolio with administrative services, including providing key management personnel to the Portfolio. In return the Manager receives an administrative fee which is allocated among the Series based on the average net asset value of each Series. Administrative expenses (excluding GST) paid by the Portfolio to the Manager for services provided by ATB Financial and its subsidiaries were \$8,057 for the period ended December 31, 2025 (\$5,213 - December 31, 2024).

As at December 31, 2025, ATBIM held 617 redeemable units of Series A, valued at \$9,174 representing 0.003% of the total net asset value of the Pool.

ATBIM established an IRC which acts as an impartial and independent committee to review and provide recommendations or, if applicable, approvals with respect to any conflict of interest matters. IRC oversight ensures that there are no conflicts of interest that would be harmful to unitholders.

Management Fees

ATBIM receives management fees of 1.75% per annum for Series A and 0.75% per annum for Series F1. The management fees for Series A and Series F1 are calculated as a percentage of their net asset value as of the close of business on each business day. Management fees for Series O are payable directly to the Manager by Series O investors and not by the Pool.

For the period ended December 31, 2025, the Pool paid ATBIM management fees of \$57,395. The Pool's management fees were used by ATBIM to: pay costs for managing the investment portfolios; provide investment analysis and recommendations; make investment decisions; purchase and sell investments; and provide other services. There are no trailer fees associated with the Fund.

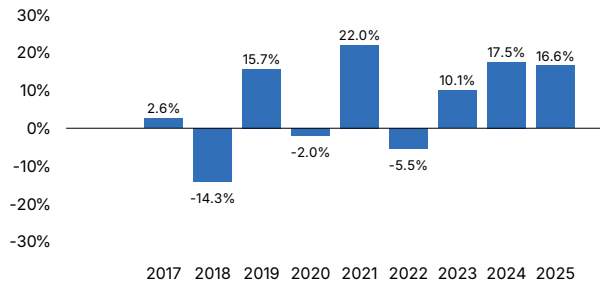
Past Performance

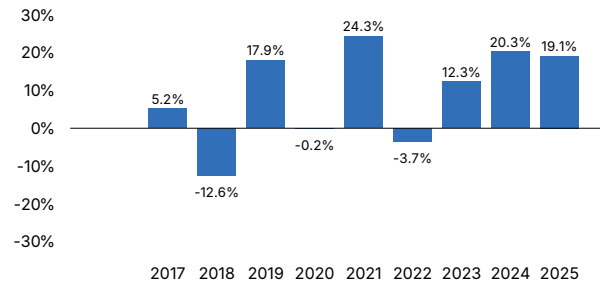
Year by Year Returns

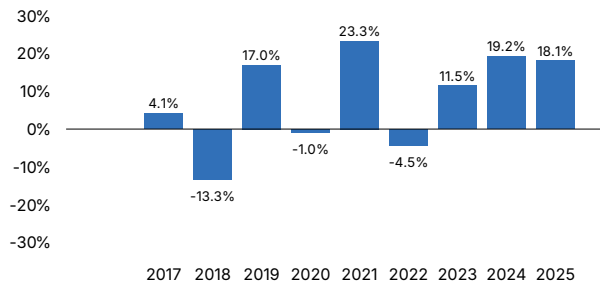
